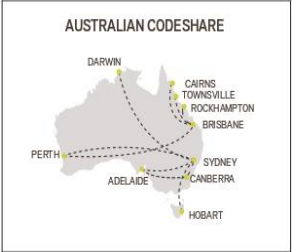
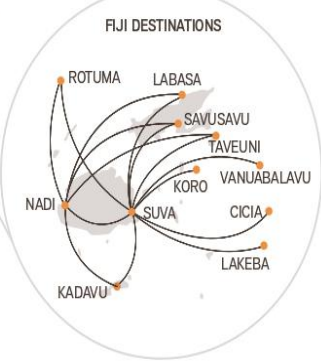
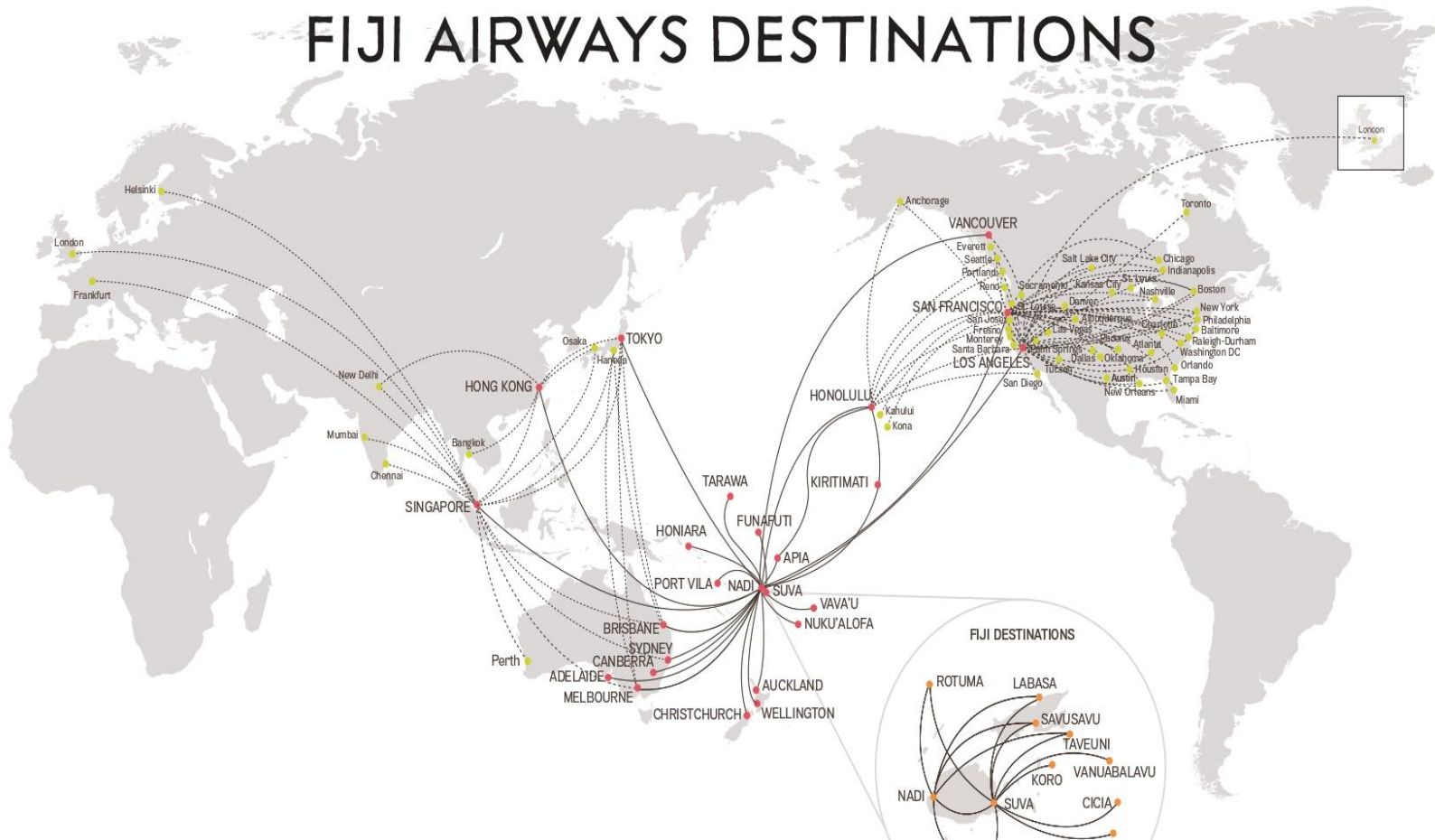


MAP OF FIJI

Opportunities in the Agriculture Sector



- Up to 498,000 hectares of land suitable for agriculture.
- Very low entry cost in agriculture business.
- Landholders willing to engage investors and/or develop partnership arrangements.
- Tax exemption and incentives offered for new commercial farming and agro-processing
- => Rice, potatoes, carrots, capsicum, tomatoes, fruits
- => Dairy, Dry Stock (sheep, goat and cattle)

Opportunities in the Energy Sector



- Availability of untapped renewable energy resources such as hydro, wind, biomass, solar and geothermal.
- 5 year tax holiday for a new activity in renewable energy projects and power cogeneration
- Duty free importation of renewable energy goods

Opportunities in the Fisheries Sector



- Large Exclusive Economic Zone, which covers 1.29 million square km of sea.
- Offshore (tuna and pelagic fish)
- Coastal fishing
- Aquaculture (Prawn, crab, fish and seaweed)



Opportunities in the Forestry Sector



- Mahogany plantations in Fiji are a unique resource with standing forests over 40 years old.
- Attractive Exports; higher value thru value addition.
- Great opportunities for Sandalwood, Teak and Pine.

Opportunities in the Health Sector



Income tax exemption for establishment of a new hospital based on capital investment levels:

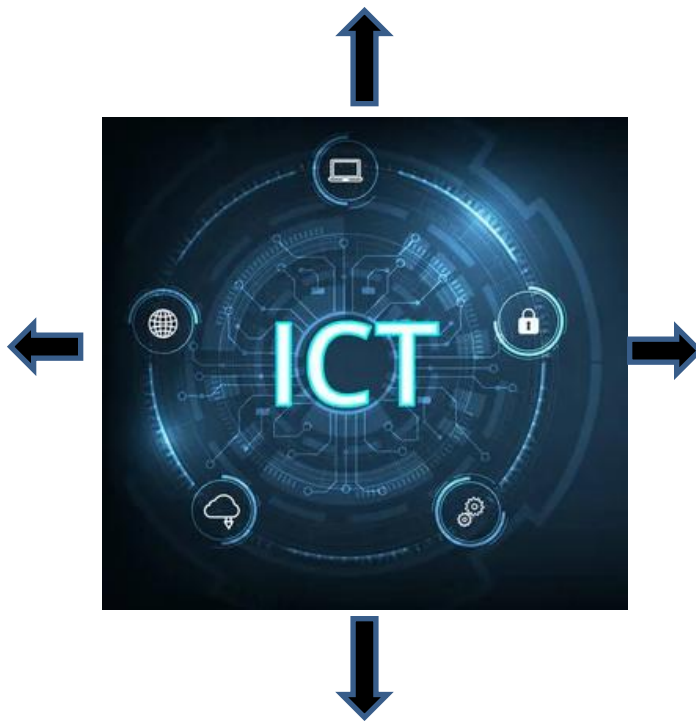
- Capital Investment from \$2.5m - \$5m for a period of 7 years
- Capital investment from \$5m - \$10m for a period of 13 yrs
- Capital investment of more than \$10m for a period of 20 consecutive years.

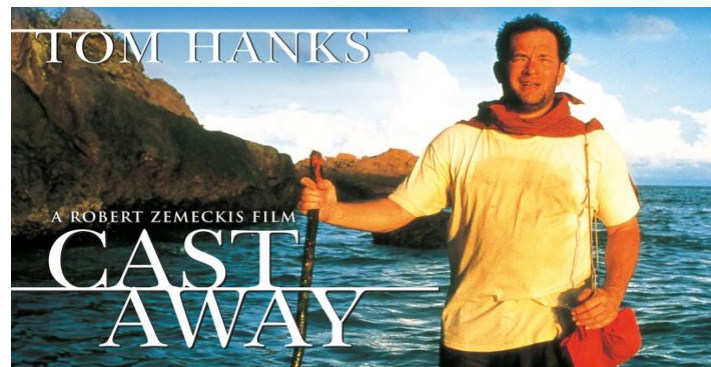
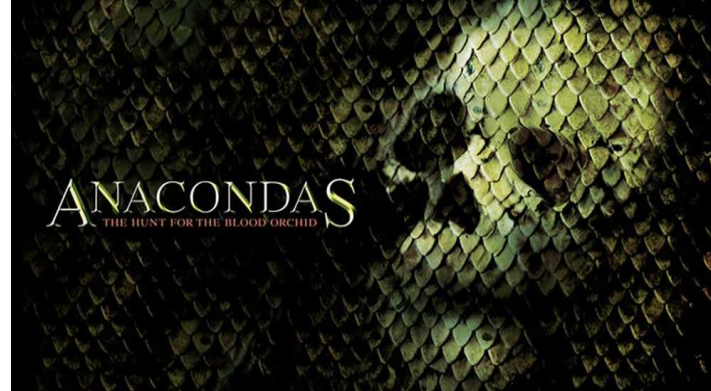
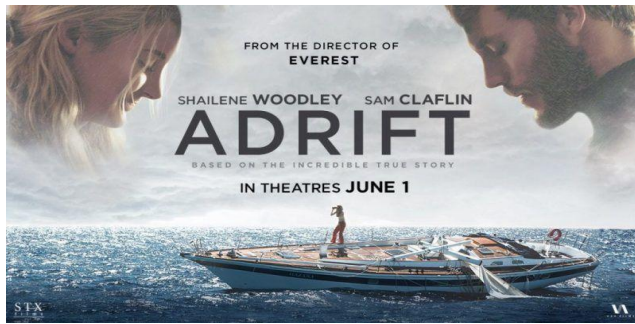
- Fiji is a consistent exporter of minerals, primarily gold for over 85 years now.

 - World class accommodation and recreational facilities.

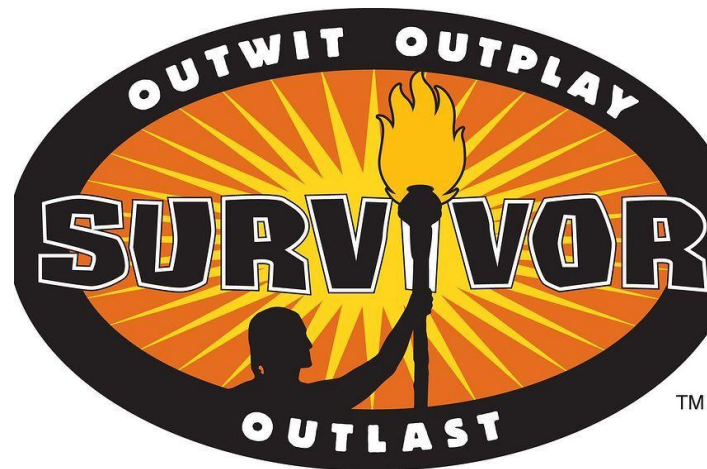
