

Decline in Motor Car Exports in 2020

India exported about USD 4.6 billion worth of motor cars and other private passenger vehicles to the world in 2020, declining by about 34 per cent over USD 7 billion in 2019.

Of India's major export destinations, exports declined mainly to Mexico, USA, Saudi Arabia, South Africa, Chile, UAE, Nigeria, Peru, Nepal, UK, Canada, Tunisia, Indonesia, Japan, Ethiopia, Bangladesh, Bolivia, Kuwait, Philippines, Bhutan, Oman, Qatar, Costa Rica, Guatemala, Uruguay and Colombia, among others.

However, the same increased to Egypt, Iraq, Australia, Brunei, Morocco, Somalia, Sudan, New Zealand, Ghana, Djibouti, Puerto Rico and Cote D' Ivoire, among others.

The following table highlights the decline in export of motor cars and other major private passenger vehicles in 2020 at HS Code 8-digit level.

While a second wave of the Covid-19 pandemic is knocking our doors, we hope exports do not take a further hit in 2021.
