

## India's Exports to UAE with Growth Potential

United Arab Emirates (UAE) is one of India's major trading partners, and is an important source of crude petroleum, non-industrial diamonds and gold for India.

India's major exports to UAE include articles of jewellery, petroleum products, light vessels, electrical machinery and equipment, articles of apparel and clothing, iron and steel, articles of iron and steel, machinery and mechanical appliances, auto and auto components and organic chemicals, among others.

India exported about USD 29.7 billion worth of merchandise products to UAE in 2019, and UAE had a share of about nine per cent in India's total merchandise exports to the world. However, India was a net importer and had a trade deficit of about USD 1.2 billion with UAE in 2019.

The following table represents India's exports to UAE (other than its major exports) that have growth potential in future. These products witnessed positive annual growth in India's exports to UAE between 2015-2019, as also in UAE's imports from the world.

With relations between the two countries growing strategically over the years, Indian exporters can take advantage of the increasing market opportunities posed by UAE.
