

India's Exports to Cambodia with Growth Potential

India and Cambodia enjoy warm and cordial relations, and the two are part of the India-ASEAN Free Trade Agreement. India exported about USD 203 million worth of goods to Cambodia in 2019, and imported goods worth about USD 47 million from the South-East Asian country.

The following table highlights India's merchandise exports to Cambodia in 2019, which have the potential to grow in future. These products reflected positive annual growth in India's exports to Cambodia between 2015-2019, as also in Cambodia's imports from the world during this period. These products also constituted about 20 per cent of India's merchandise exports to Cambodia in 2019, and about 8 per cent of Cambodia's merchandise imports from the world in 2019.

Since Cambodia has a very low share in India's exports of these products to the world, the two countries should further enhance their trade ties and gain from their complementarities in trade.
